#### **FACILITY INFORMATION**

The competition pool is a 6 lane, 25 yard pool. The pool is 9 feet at the start end and 3.5 feet at the turn end. Colorado Timing Systems: Dolphin Electronic Start system.

Spectator seating is on the pool deck at the turn end of the pool. There will be no chairs allowed on deck (except coaches and officials), with the exception of handicap accessibility by permission of meet director.

## \*Crash Zones (will open at 8:45AM)

- Outside patio at south (turn end) of pool (weather pending)
- Gymnasium on upper level of building at north end of pool (if raining or too cold)

#### \*Concessions

Concessions will be available throughout the meet, either outside on pool patio, or outside of gym, depending on weather.

## \* Enter Building at West Entrance (Main Entrance facing ball fields):

- Check-in at member services.
- Prospective members 16+ years of age must have photo ID.
- Prospective members will need to sign waiver at check-in.
- Follow arrows to crash zones.

#### WARM-UP AND TIMING ASSIGNMENTS

Each team will be assigned lanes and times for warm-ups. These assignments will be made after the entries are received. Teams will be contacted with their warm-up and timing assignments.

#### **RULES**

This meet is governed by the current National YMCA "Rules that Govern YMCA Competitive Sports."

#### **ELIGIBILITY**

A swimmer's age as of June 1, 2024 will determine their age for the meet.

#### **ENTRY DEADLINE**

All entries must be received by Tuesday, May 28, 2024 by 12PM. Please email entries to JCHAMBERS-SCHWOB@K3YMCA.ORG.

Please submit electronic entries in a format compatible with Hy-Tek Meet Manager.

#### **ENTRY LIMITS AND FEES**

Individuals are limited to 3 individual events and 2 relays.

A flat rate of \$10 per swimmer will be charged for this meet. Please make checks payable to: Kankakee Area YMCA. Payment is due before the 1st splash of the day!

#### CHECK-IN

This meet will be positive check-in. Coaches will need to turn in entry sheets by 9:50AM.

#### **BULLPEN**

A bullpen will be provided for 10 and under swimmers.

#### **ATHLETES WITH DISABILITIES**

In accordance with USA Swimming Rules, Articles 105 and 202.2.13, the Meet Referee has the authority to accommodate athletes with disabilities. It is the responsibility of the coaches or athletes to contact the Meet Referee prior to the competition with specific requests.

### **AWARDS**

Awards will be given for heat winners.

#### **SCORING**

This meet will not be scored.

#### **RESULTS**

Results will be emailed to each team within 48 hours of the meet. Live results during the meet may be viewed on Meet Mobile.

#### CONDUCT

- \*All coaches are responsible for the conduct of their swimmers and will see that their club has proper supervision at all times.
- \*Meet Marshals have the authority to remove any swimmer and/or spectator from the meet for any violation such as improper behavior, damage to property, etc.
- \*Please encourage your parents and swimmers to clean up after themselves.
- \*In accordance with the Federal Video Voyeurism Prevention Act of 2004 the use of camera phones or video recording devices in the locker rooms is prohibited. Use of audio or visual recording devices, including cell phones, is not permitted in the changing areas, restrooms, or locker rooms, or in areas behind the starting blocks.
- \*Flash photography is prohibited in the pool area when the athletes are on the starting blocks.
- \*Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited.
- \*Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coached, officials and/or spectators are present.

#### LIABABILITY WAIVER

In consideration of the acceptance of this entry, intending to be legally bound, I/we hereby waive, and release any and all rights and claims for damages which may accrue against the Kankakee Area YMCA, and their representatives, employees, or successors, for any and all injuries suffered by me or any contestant or representative in said meet as a representative of my club.
